#### Accepted Methods of Payment.

We accept most major credit cards through Pay Pal.

#### World Wide Shipping Time.

The time needed to ship merchandise will vary depending on the shipment's location and the particular time of year.

Dependant on location Customers Orders are usually shipped within 3-5 business days upon payment confirmed. (Monday-Friday), excluding holidays.

Please note that the shipping and billing addresses must be valid addresses. (PO boxes are not accepted.)

Military and P.O. boxes: Due to shipper restrictions, shipping is **not** available to A.P.O. / F.P.O. and P.O. Box addresses.

#### Shipping Methods.

Merchandise will be shipped using Insured Royal Mail where possible.

### **For all orders outside the U.S.A.**

Free Postage & Packaging to most major International cities.

All tracking information will be sent to you via email as soon as the order is shipped. Blue Moon Marketing Systems Ltd, reserves the right to request identity verification via fax or email for our international customers paying through Pay Pal.

## **Damaged Shipments.**

Damaged shipments from handling must be claimed with the freight carrier. If any cartons are missing or damaged, be sure to note this on the freight bill. If you notice concealed damage after the driver has left, keep all the packing and call the freight carrier to return and inspect the damage and file a claim. We are not responsible for damage caused by the freight carrier.

## **Customs, taxes and Import Duties.**

1. You may be subject to customs import duties and taxes that may be payable once the parcel reaches your country. Any Additional charges for customs clearance must be paid by you.
2. We have no control over any additional charges and cannot envisage what they may be. Customs policies vary widely from country to country.
3. You should contact your local customs office for further information. Additionally, when ordering from Blue Moon Marketing Systems Ltd, you are considered the importer for all official records and must comply with all laws and regulations of the country in which you are in receipt of the goods.
4. Please note that your country may add an import tax or duty to the parcel because it contains a commercial invoice. The buyer is responsible for any and all additional destination tariffs.
